- ➤ A body corporate that is being wound up, is in liquidation or receivership, or is subject to statutory management under the Corporations (Investigation and Management)

Outlined below are the standards of behaviour expected of NZSSA executive Committee Members as declared in the New Zealand Sterile Sciences Association Constitution & Rules 2017. In agreeing to be part of the Executive Committee, each member must also sign an agreement to adhere to these codes at all times. Committee members shall:

- Be diligent in their role
- Attend seventy-five percent of committee meetings each year. In unavoidable situations forward their apology prior to the meeting.
- Understand that they shall receive reasonable reimbursement for travel costs to attend executive meetings.
- Treat all people associated with the NZSSA, including members, external stakeholders, and other Executive Committee Members with respect
- Always consider the welfare of the NZSSA members above own gain.
- Attend to their fiduciary responsibility and make decisions based on what is best for the NZSSA, not for individual interest or gain
- Not take advantage of their position on the Executive Committee in any way
- Declare any Conflicts of Interest as they arrive and act to ensure that these conflicts do not pose a risk to the organisation (please complete the conflict of interest form on the next page).
- · Advise if you are not able to be certified as an officer of a charity
- Understand and behave appropriately as an officer of a registered charity
- Committee members are required to advise the President immediately if they are charged or being investigated either criminally or professionally.
- Be open to feedback from members and respond appropriately
- · Be honest at all times
- Act as a positive role model with respect to good behaviour
- Adhere to the policies and procedures established by the Association
- Adhere to the legislative requirements of the Association
- Respect the resources of the NZSSA and only use these in Association related business
